Police Reports and Activity in Perry Township  
**Month of June 2021**

### **June 1, 2021**

Officers were dispatched to the 8100 block of Copperfield on a suspicious person. Officers found the individual and discovered that he did not have a permit through Perry Township. He was told to call the office to obtain a permit.

### **June 1, 2021**

Officers were dispatched to Riverside and Bethel on a disabled vehicle. Officers waited until the Tow truck arrived. Officers cleared the scene.
