Police Reports and Activity in Perry Township  
**Month of October 2019**

**October 1, 2019**

Officers were dispatched to Lane Rd on a suspicious person. Officers arrived on the scene and searched for the individual but they were unable to locate the subject.

**October 1, 2019**

Officer conducted a traffic stop for a license plate violation. It was discovered that the driver's license was expired. The driver was issued a citation for no operator's license and expired plates and released on a summons to appear in court.

**October 2, 2019**

Officers were dispatched to the 2500 block of Snouffer Place on a nature unknown. Upon arrival Officers spoke with the caller who stated he wanted a medic. The medics were dispatched and the subject was taken to the hospital for observation.
