Police Reports and Activity in Perry Township  
**Month of January 2020**

**January 1, 2020**

Officers were dispatched to the 1300 block of Clubview S. The caller thought that a utility company installed cameras in front of her daughter's window. Officers spoke with company and stated that they installed a GPS unit not a camera. Officers returned to patrol.

**January 3, 2020**

Officers were dispatched to the area of I-270 and US 23 on an assistance to Sharon Township Police searching for a suspicious person possibly with a gun. Officers arrived, checked the area but were unable to locate anyone matching the description given.

**January 3, 2020**

A resident reported receiving harassing messages. Information showed the number belongs to an elderly woman whose number had been spoofed. A report for documentation was taken.

**January 3, 2020**

Officers were dispatched to the area of 2400 Merbrook Rd on multiple suspicious persons. Officers arrived and did not locate two males matching the description given. They were identified and found to be working for a tree and mulch service. They did not have the proper permit and were referred to the administrative office to obtain one. The parties were asked to leave the area until a permit is in place.
